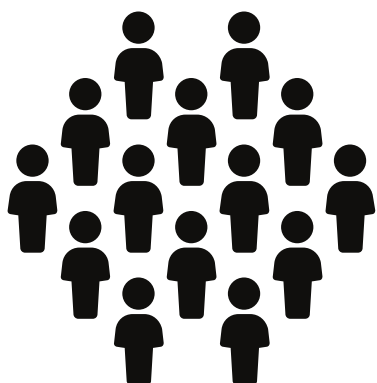

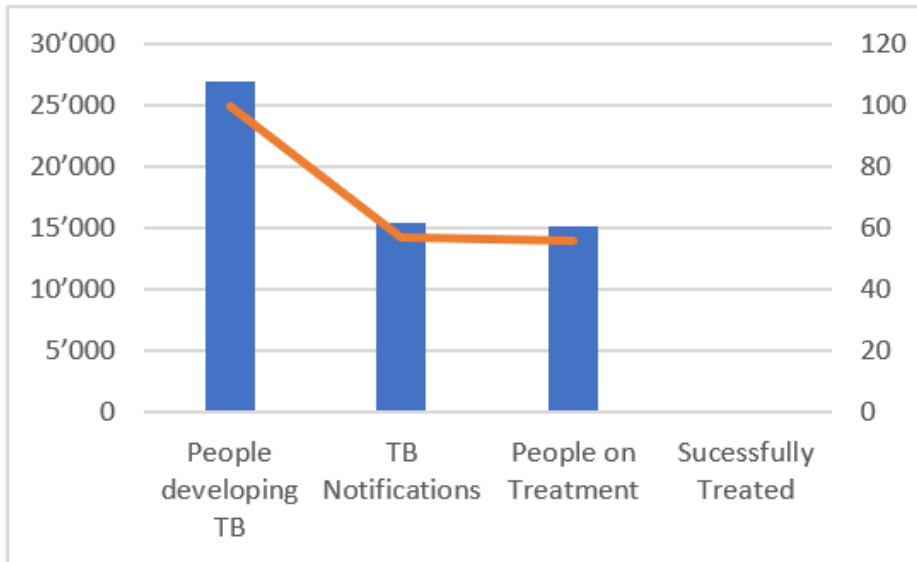

- 11,867 missing people with TB (2,805 were children)
- 2,600 People died because of TB
- 108 Laboratory confirmed people with MRD/RR-TB (WHO data, 2020)
